Program Rules

1. Horse must complete the dressage test and the score must be officially eligible for NEDA Fall Festival of Dressage class awards. Prize money will be distributed to the highest scoring rides, regardless of official placing in the class.
2. Horse must be ridden by and / or owned by a Gold Member, in good standing, of DressageClinic.com at the time of the competition.
3. Prize money will be officially distributed by NEDA check after the competition. Before money is released, winners must fill out and sign a Cash for Gold form indicating Gold Member(s) name, address, tax information, and amount breakdown to whom money will be sent. If necessary, an American W-9 form must be completed; taxes may be withheld for foreign winners. If both Rider and Owner are Gold Members, money may be split or not split as they agree.
4. In the case of a tie, Prize Money for place(s) will be added and divided in half for each Horse. Four places will be awarded in each class.
5. Prior to competition Riders / Owners may sign up as Gold Members at www.dressageclinic.com or Riders / Owners may obtain Gold Membership at NEDA Fall Festival of Dressage (see Andreas Stano on the show grounds) so long as membership is successfully completed before horse enters the ring.
6. Undistributed prize money will be held for the 2012 Cash for Gold program.
