

NEDA SPORT HORSE HANDLING CLINIC

May 8, 2010

Brookside Equestrian Center, 90 Tiff Road, North Smithfield RI

This sport horse handling clinic is open to anyone to attend with any type or age of horse. Auditors are also welcomed. The cost will be very low (\$20 participant with horse or \$10 auditor for NEDA members and an additional low fee for non-members. There is also a special student rate) courtesy of NEDA and of the instructor, Bobby Murray, and Brookside Equestrian Center. The purpose is to provide instruction on how to handle your horse effectively, whether foal or mature breeding animal. Although handling for dressage sport horse competition is emphasized, this clinic is also suitable for horses going to breed inspections as well as those competing in other disciplines (hunter breeding, Arab sport horse in hand, etc.) or for owners who just want to improve their in-hand technique.

Instructor Bobby Murray, Stallion and Young Horse Manager at Pineland Farms, is a very successful handler, having major wins at the NEDA Fall Festival, Dressage at Devon, Breeder's Championship Finals, etc. as well as at breed inspections. Bobby takes great pride in presenting each horse to the best of its capabilities. He is also a very talented and patient instructor. Clinic Fee Schedule

All "Participant" applications must be post-marked no later than April 30th

Requirements for horses:

Owners must provide proof of current vaccinations (health certificate) and a negative Coggins by May 1st.

Stabling:

- There is a \$10 truck in fee if working out of your trailer..
- A limited number of stalls are available at a cost of \$25 a night, \$15 for a day stall.. Bring your own bedding, hay and grain.
- ***Stall fees are to be paid directly by separate check to Brookside Equestrian Center not NEDA.*** Contact Lyn Spinella at 401-766-5400 or lyn@brooksideec.com for details.

Hotel and Concessions:

- The host hotel will be the Comfort Suites, 1010 Douglas Pike, Smithfield, RI, 401-231-6300. Special rate of \$75/room. Use "NEDA" as the rate code. Includes a continental breakfast. About 10 minutes from Brookside.

- There will be concessions at Brookside Equestrian Center for both breakfast and lunch.

Schedule:

Unless otherwise notified, the clinic will start at 9:00 AM and will take place in a covered arena.

Directions to the Facility:

Brookside Equestrian Center is located at 90 Tiff Road, North Smithfield RI. The facility phone is 401-766-5400.

From Points North: Route 146 SOUTH to the Pound Hill Road exit. At the bottom of the exit ramp, turn RIGHT on to Pound Hill Road. Follow the signs for the Industrial Park.

At the end of Industrial Park, turn RIGHT onto Route 5 North. Turn LEFT onto Charon Drive approximately one block down.

Make an immediate LEFT on to Black Plain Road and then an immediate RIGHT onto Tiff Road. Follow Tiff Road to the end. Cross a little cement bridge. Bear LEFT after the bridge and take the SECOND driveway on the LEFT at 90 Tiff Road. (You will see the sign for Brookside). The driveway will take you between a log cabin and a small barn. Remain on the driveway which will take you up the hill to the big barn and the parking lot.

From Points South: Route 95 NORTH to Route 146 NORTH (Lincoln/Woonsocket exit). Stay on Route 146 NORTH towards Worcester and exit at Pound Hill Road. At the bottom of the exit ramp, turn LEFT onto Pound Hill Road. Follow the signs for Industrial Park. Pick up directions at second paragraph of "From Points North".
