



NEW ENGLAND DRESSAGE ASSOCIATION

YEAR-END SPORT HORSE BREEDING AWARDS

Sponsored by Mountain Horse

QUALIFICATIONS:

- > All breeds are eligible.
- > Owner(s) of the horse (and riders in Materiale classes) must be current 2010 NEDA members by October 5, 2010.
- > Scores from any dressage sport horse breed show recognized by both USEF & USDF in any Zone.
- > Scores must be earned during the Competition Year, September 30, 2009 through October 5, 2010
- > Championship and IBC (breed specific) classes are NOT eligible.

AGES, CATEGORIES & PLACINGS OFFERED:

- > Foals of 2010, Yearlings, Two Year Olds, Three Year Olds, Mares - Four Years Old & Up, Stallions - 4 Years Old & Up, Materiale, Amateur Handler.
- > Awards to six places in each category (separated by sex for each age group if there are more than 3 entries for each sex, otherwise combined); Materiale (not divided by sex but by age, 3 year olds and 4/5 year olds, if there are more than 3 entries for each age group, otherwise combined).

SCORES TO SUBMIT:

- > Submit your three (3) best scores ONLY, with restrictions as listed below.
- > A minimum of one (1) of the scores must be from a show in New England or New York.
- > Submit scores from three (3) different shows with two (2) different judges.
- > The **sum** of the three scores will be the horse's year-end score. If there is a tie, then it will be broken by the highest single score submitted.

WHAT AND HOW TO SUBMIT:

- > Submit one form for each horse. (For Amateur Handler, submit one form per handler and put in owner section.)
- > Attach a copy of the owner's current USDF membership card. (Amateur Handler card for that category)
- > Attach a USDF printout of recorded scores with scores to be used highlighted (may be downloaded from USDF website, usdf.org) **OR** a copy of each class score sheet (one per page). USDF printout is preferred when possible. It is acceptable to submit a combination of USDF printout and class score sheets.
A class score sheet must include:
 - > Horse and horse owner's name.
 - > Class with age & sex of horse; and name, location & date of competition.
 - > Name(s) of officiating judge(s) for test and final percentage (average of all judges' scores for class)

Scores *MUST* be postmarked by OCTOBER 5, 2010 to be eligible for awards.
